

<u>Upcoming Events, Dates and Highlights</u> Rickreall Rock and Gem Show – April 27-29:

The Rock and Gem show is a three day event (Friday, Saturday, and Sunday) that requires a substantial volunteer effort. Friday is the most demanding day with elementary students from the surrounding schools passing through the exhibit. Our club sets up 3 or 4 panning tubs and sells baggies of gold for the students to pan. Along with being a lot of fun with the kids it's also a really good revenue source for the club. Saturday and Sunday are not quit as demanding but we still need a goodly number of volunteers to fill in. President Louie will have volunteer signup sheets at the April 19th meeting.

April's WVM Meeting Program:

April's meeting program will feature a mini-workshop conducted by Tom Quintal and Paul Messersmith. An overview of mining techniques and practices as well as a broad array of simple equipment and gadgets will be displayed and discussed. This is an excellent opportunity for especially newer members to prospecting to carry away some ideas of "what, where, and how." Q & A session will follow.

April's Outing:

April 14-15 brings the Beverly Beach (North of Newport) Club Outing. This outing features beach sand prospecting and sluicing. Wes Jeffers and others have fabricated a special type of sluice that captures the very fine gold found on the beach in the black sand – found especially near the small creek that flows into the ocean about ½ mile up the beach from the park. A small (3 foot) regular sluice is also effective. The challenge comes in separating and panning the gold from the black sand. Metal detecting is also available but you will have to obtain a detecting permit from the park ranger to use your device on the beach "within the boundaries" of the park.

May's Workshop:

Finding, filing, and maintaining mining claims, working with BLM's LR2000 on-line Claim Finder system, and general map reading and intelligence are the topics covered in this workshop. Participation is limited to 10 participants and there's a \$10.00 fee to cover the cost of the worksheets and handouts. Paul M. conducts this workshop in his home in Albany. It runs from 10:00 to about 3:00 with a lunch break – the exact Saturday date is yet to be determined. An initial signup sheet was available at the February meeting with nearly the maximum number of folks showing a preliminary interest. We'll finalize the class roster at the April meeting. If the interest is high enough, we can schedule a second workshop for sometime around mid-summer.

Government Affairs Update:

Petitions were circulated at the GPAA gold show in Salem which supported amendments to HB2085, HB2857 and SB38 to exempt increases in fees for filing "proof of labor" documents with the Count Clerk. Tom Q., Gary S., Tom Kitcher (Waldo Mining Group), and Paul M. attended two Senate Revenue Committee hearings – testifying at the first – to bird-dog these amendments. It would appear, at least at the time of this writing, which the amendments have met with general acceptance among the committee members. Those that we submitted are being revised by the Legislative Council to eliminate any potential conflicts with other ORS's. The petitions are being scanned and emailed to key people around the state to be forwarded to their respective senators and representatives.

Hopefully by the April meeting we will have more definitive information available to report to the membership.

Metal detecting permits and requirements is another area that is being investigated by the committee. Tom Q. and Gary S. have had numerous meetings and delays over the past four years with the Parks and Recreation Department with no resolution of the issues forthcoming. Tom, Gary, Cliff Winston (Cliff's Metal Detectors), and Paul M. met with Parks personnel recently to get the talks started again. As it stands right now, if you are detecting in state parks or on beaches abutting a state park, you must have a permit that is issued free of charge. There are many issues surrounding this seemingly simple task and requirement. The committee will elaborate more at the April meeting.

We did manage to arrange for a meeting with a number of "Parks' Managers" and our committee for sometime in May. Hopefully we can begin to get closure on this issue. Respectfully submitted,


