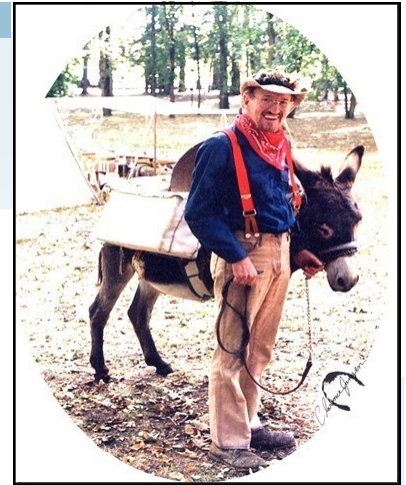

Meeting Minutes May 17, 2018

Hello there miners! Tonight's meeting was called to order by Pres. Jim P. and then he led us in the Pledge of Allegiance to our flag. Don Esch told us about a trip he just returned from in Southern Oregon. He spent time with Trevor S. and Sam S. and said the area they have down there is quite impressive. There is history at a creek there that was the first gold strike in Southwest Oregon. Sam has been doing a lot of exploring and studying of that area and he has found some old mining camps with artifacts still in place, an old hand dug ditch about two miles long, and an area above that where hydraulic mining had been done. Originally, the old timers had to remove 20-30 feet of overburden to get down to the creek's bedrock. Pretty amazing. Anyway, he had a lot of fun down there and since he wasn't in the water he decided to do some metal detecting on the hillsides. He found one area where there were some "hot" rocks that once crushed contained quite a number of gold flakes. He brought in some of those rocks for us to look at and you can see gold specks in them. So don't discount hillsides above creek beds where gold has been found.

Minutes –continue

Rick S. gave us the Treasurer's report for last month's finances. Patti made the motion to accept the report as read, Tom Q. made the second, and the motion was passed by vote. He also said there are still some WVM patches available for sale for \$5.00 each but the caps are all gone. And the new revised membership handbooks are finished and are available now. If you want a new one mailed to you send a check for \$5.00 (that's three dollars for the book and two dollars for the postage) to WVM, P.O. Box 13044, Salem, Or. 97309-1044 or you can get one at the meetings for \$3.00 each. You'll find them easier to read and full of new and useful information.

Larry C. gave us his Claims report stating that mining season is coming up and that's exciting. The outing to Vincent Creek will be over by the time this letter is published but as a reminder if you plan on being on that claim in the future remember that the area is an animal protected corridor. Be sure to close the gate behind you, either going in or out, and you must have your WVM dash card on display while there. Be sure to keep the claim site clean and do no damage to the trees or terrain. Also, at the Golden Dollar claim on the Calapooia, the road is now open but the Forest Service is proposing a corridor, from the forest line up to where the 18 Creek joins the Calapooia, that restricts all camping. So, if that proposition passes, there is no more camping at our claim. Claudia W. said they can't keep us from camping on our claim and Larry said he wrote the F.S. a letter stating that fact. We'll see what kind of reply he gets, if any. Jim reminded us that we need to document the dates and times you spend on any of our claims doing prospecting, cleaning up trash, improving trails etc., so that information can be sent to Larry or

Jim. This info is compiled each year for the work waivers and sent to the B.L.M.

The WVM newsletter had not been received by the time of tonight's meeting so there was no discussion about last month's minutes.

Our upcoming outings and events are as follows: June 14th-18th is the Quartzville Miner's Rendezvous. This is on Quartzville Creek at about mile post 23 in the Old Miner's Meadow outside of Sweet Home. This is our biggest outing of the year so all of you are encouraged to come and enjoy the festivities. You can come for the weekend or a day. There will be contests for kids and adults on Saturday with prizes awarded to the lucky winners. There is the famous duck race where you can buy a chance to share the purse. Saturday at noon is a wonderful pot-luck lunch. WVM will supply the burgers, dogs, a deep-fried turkey (thanks Jeff and Debbie), table service and water you bring the sides. Tom Q. reported that there was a hearing on the 700 DEQ suction dredge permit in the Oregon Supreme Court. Our Attorney, James Buchal, made a pretty fair presentation. Some of the judges asked some very good questions in regards to DEQ's claim that we as miners are adding pol pollutants back into the streams. These claims didn't make much sense to them. Anyway, you must have a "copy" of the 700 permit in your possession while working in a stream even if you are just using a sluice. Panning doesn't require it. You can get the permit on-line on the DEQ website at www.oregon.gov/DEQ. No news yet in regards to that hearing and it may take some time before we do. Let's hope for the best.

Trudy S. generously donated (along with tons of other stuff for the raffle table) a lovely miniature tea service. This was hand painted and trimmed in 24 karat gold so Jim decided to auction it off. 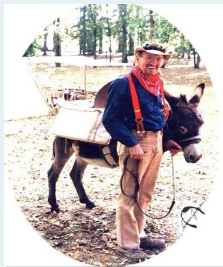
